New Wilbert Jewelry Notification



P640B

Wilbert Funeral Services, Inc. is happy to announce the addition of two new replacement jewelry items.

The **P640B** Loved & Cherished Pendant™ replaces the old **P640A** Loved & Cherished Pendant.

The **P630B** Heart in Bloom replaces the old **P630A** Cameo Rose™ pendant.

Due to an entry error the current price list incorrectly lists these items for sale at \$110 each. The correct price to the Licensee for both of these items is \$190 each.

In the past the **P630A** Cameo Rose was sold at \$272 and the new **P630B** Heart in Bloom is being sold at \$190. The new **P630B** is actually smaller in size than the old **P630A** and therefore requires less silver to manufacture. The overall cost of silver has dramatically risen recently so the actual cost per ounce of silver to make this item has gone up.

In the past the **P640A** Loved & Cherished was sold at \$120 each and the new **P640B** Loved & Cherished is being sold at \$190 each. The size of this new pendant did not change much so the amount of silver required remained the same while the cost of silver per ounce went up. This is why the cost per piece has increased.

Wilbert originally purchased the **P630A** and **P640A** when the silver market was at approximately \$16 per ounce to \$17 per ounce. Recently silver has increased in cost to as high as \$42 per ounce. The new versions of these pendants were purchased when the price of silver was approximately \$32 to \$34 per ounce cost.

Chris Wood has a son who is a police officer. So when Chris, of Washington Wilbert Vault Works, Inc., Laurel, MD, heard on the news about a fatal crash involving a Prince George's County police officer, his first thought was to make sure his son was safe. His second thought was the Wilbert Commemorating First Responders Program.

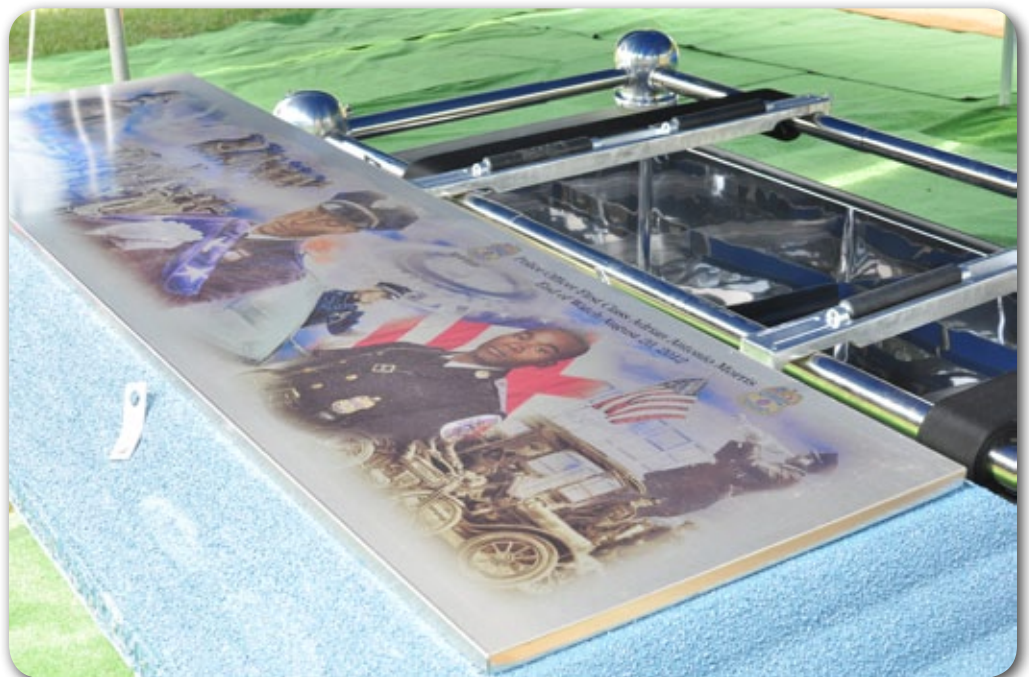
Officer Adrian Morris, 23, of the Prince George's County Police Department was killed August 20, 2012 while in pursuit of a suspect in an attempted robbery at a gas station in Laurel. The police car carrying Officer Morris and his partner, who had non-life threatening injuries, crashed into a guard rail on Interstate 95 and landed in a ditch. Officer Morris died on the scene.

With the help of his son, Chris Wood reached out to Prince George's County Fraternal Order of Police President Vince Canales to offer the services of

the Commemorating First Responders Program to the department and the fallen officer's family. The police department liaison officer worked with Chris and the Donald V. Borgwardt Funeral Home to honor Officer Morris with a customized Wilbert Stainless Steel Triune® burial vault. The cemetery, Lakemont Memorial Gardens in Davidsonville, MD, held a full WilbertWay® graveside service.

The importance of the Commemorating First Responders Program in providing support and honoring the service of those killed in the line of duty is not lost on Chris. Even before his son became a police officer, Chris was instrumental in the development of the Commemorating First Responders Program, brainstorming with WFSI President Dennis Welzenbach and WFSI Executive Vice President Terry Whitlock on ways the company could do more to honor fallen first responders.

Chris also was presented with an inscribed crystal from the Prince George's County Police Department.

Being honored himself was never on Chris' radar.

As a youth, Officer Morris had gone through the Prince George's County Police Department's Law Enforcement Explorers Program, a yearlong program for youths ages 13-20 to help them learn more about what police do and to spark interest in law enforcement careers. The Explorers decided to name its yearly event the "Annual Officer Adrian Morris Explorer Awards Banquet" and invited Chris to attend on February 22nd. "My son kept badgering me to attend the banquet, so I went," Chris said.

At the banquet, to his surprise, the Prince George's Police Department recognized Chris, Washington Wilbert Vault Works, Inc., and the Commemorating First Responders Program for the services provided for Officer Morris. Chris was presented with an inscribed crystal from the police department and a certificate of appreciation from the Explorers Program. "I even received a 'standing O.' It was a great honor to receive recognition on behalf of the program," Chris said.

Remember to verify that all racking components are stamped with load capacities; the racks must be built to withstand the weight of burial vaults.

Recent television news series headline:
Veterans at Pulaski County cemetery buried in unsealed liners, and it angers families

Television station WDBJ-7, Roanoke, VA recently did a series on the use of grave liners for no-cost veterans' burials, finding some people upset when realizing they were not sealed burial vaults.

A Vietnam veteran's widow was very distraught when she learned — *after* her husband's burial — that the grave liner is likely to take on water. She thought she was getting a burial vault and didn't really understand the difference, until it was too late.

She claimed that she was not made aware of the difference between government-issued burial liners and sealed vaults, nor was she told about the VA credit available to her towards the purchase of a vault. Dabbing her eyes with a tissue, she said, "I don't understand why I wasn't told. Seems like people down at the (Virginia Department of Veteran Services) office, it would have been part of their job. To tell you, to tell me, tell anybody."

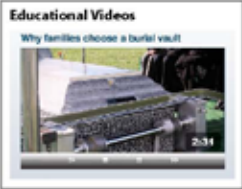

Liner Load Changes Coming as of March 1st

As mentioned in the February edition of the eNews, WFSI is in the process of changing the way we ship our Liner Loads. As of March 1st, all Liner Loads will be shipped ONE-WAY. You will now be charged for only the One-Way mileage and not be charged for the "empty" miles to have that truck return to the distribution center (Belmont or White Bear).

NOTE: There will no longer be deliveries made by WFSI controlled vendors (CH Robinson) using 48' trailers with belly attachments. All Liner Load deliveries will be made using 53' air ride equipped trailers.

With the Liner Loads only being shipped to you one-way, you will now have the opportunity to utilize our broker—C H Robinson—to arrange for your returns of skids, crates, racks, corner supports, along with other items with a Less-Than-Truckload (LTL) carrier.

By combining the One-Way shipment of the Liner Load with the LTL option of sending back your returns, most Licensees would experience a 25% to 35% overall savings from your normal Liner Load and return freight cost. Individual savings will depend on your current Liner Load rate and how it compares to industry standards.

There are no changes in the way that you will arrange for your Liner Load shipments. Please continue to contact Gregg Katz (708-681-7066 or at gkatz@wilbert.com) at least 2 to 3 weeks prior to your desired Liner Load date to be added to the delivery schedule.

Your returns can be arranged with C H Robinson at any time, it does not have to be on the same day that you receive your Liner Load. To arrange for the pickup of your returns, please contact C H Robinson at least 24 hours prior to your desired pick up date. You may contact C H Robinson at:

If calling in or faxing your pick up request, please mention that you are contacting them regarding a Wilbert return.

Be prepared to provide the following information:

- Pick up location
- The description and amount of what is being returned – # of skids, crates, racks, boxes of corner supports....
- Ship to location—Belmont or White Bear

- Date of pick up
- Time of pick up – preferably a pick up window of 2 or 3 hours in the afternoon
- Contact person
- Any special instructions that will help the driver to find the location
- Billing address – if different from pick up address

C H Robinson will then prepare a Bill-of-Lading and either email it or fax it to you. You will then just need to give the Bill-of-Lading to the carrier when they arrive and make sure that the Bill-of-Lading agrees with the items that you are returning. It is important that you not add or subtract items that you are returning once you inform C H Robinson of your pick up request and what you are returning.

Many Licensees have already been contacted and given their new freight cost for 2013. If you have not received your new freight cost as yet, please contact Gregg Katz in Broadview. New or returning freight customers can also get the most updated freight cost by directly contacting Gregg Katz as well.

Please contact Gregg Katz with any questions.

Liner Load Information

Please contact Gregg Katz at ext. 145 to schedule your Liner Load date two weeks prior to the loading date. Remember that your Liner Load order should be in house at WFSI **ONE week** prior to your loading date as well. You may ask why? The one week prior to loading assures that material is transferred to the proper warehouse for your demand. When Licensees submit their Liner Load order a few days before

loading date this has caused problems. WFSI could be getting low on a product. If your order comes in a few days before loading for a large amount of that product and WFSI is loading you that day, you may receive what WFSI has on the floor – BUT – the Licensee who had their order in house one week prior before loading date might not receive this product which is not fair to all Licensees. Also if an order is not in house one week prior to the load date, then WFSI has the right to cancel your

load date and reschedule you for a later date.

Please remember if WFSI is out of stock on an item you are requesting on your Liner Load truck, and your order was not in house one week prior to load date, any items backordered will be shipped to the Licensee at the expense of the Licensee to receive backorder item/s.

WFSI has placed an order with WPS on this product, hoping for arrival by April in the warehouses. At the present time it is difficult for WFSI to figure out how many Licensees will be switching over to the speed bump bases, shown above.

We would appreciate it if you could take a moment and call the Inside Sales Dept. and let them know if you will be ordering the **C54030** for your future orders. This will help to assure that WFSI does not run into a backorder situation where the undercut bases may be substituted on your order. Once WFSI has a buying history for about three months, then WFSI will know how many to order of speed bump bases and also what to decrease in the ordering of standard 30" Strentex bases. Your help will be greatly appreciated in this matter.

Liner Load "Form N" will be updated April 1, 2013 with the new part number **C54030** Strentex 30" bases with speed bump. If you want to receive the speed

bump bases please make sure to use updated Liner Load form to assure this. Also the following items will be added to this form:

- T85** 1" Triune Tape
- K765B** 9" Roller covers with 1¼" nap
- P255A** Robust Mausoleum trays

Above items are available now for ordering on your Liner Load.

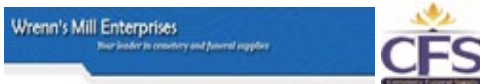

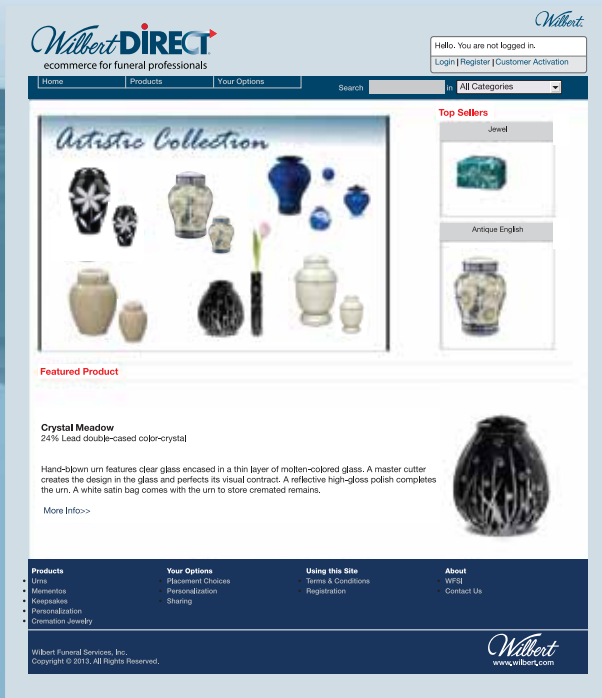
