"Taps at the Tower" program



On June 23, 2021, Michael Nash, Director of Sales and Customer Support for Wilbert Funeral Services, participated in the 2021 "Taps at the Tower" program at the National World War I Museum and Memorial, located in Kansas City, Missouri.

This is the eighth year for the Taps at the Tower

program, which started back in 2014, the 100-year anniversary of the beginning of World War I. The program is a week-long event that happens at sunset each evening. The ceremony itself consists of the presentation of colors, laying a wreath at the base of the Liberty Memorial, a recitation of the inscription on the North Frieze on the Memorial, and the playing of "Taps" by a solo bugler. Typically, the event is attended by 500-600 people nightly.

This year's theme was "Absence," a tie-in for what all Americans have been through with the COVID-19

pandemic and war losses. For the June 23 service, the museum focused on the death-care industry and front-line workers during the pandemic.



As a licensed

funeral director, embalmer, and supplier to funeral homes, the staff of the museum and memorial felt Michael was a great fit to take part in one of the ceremonies this year. Michael was honored to be the wreath bearer, placing the wreath at the base of the Liberty Memorial.

Recapping the sessions sponsored in June



On June 3rd, Mark Bartel, Chaplain and Manager of Spiritual Care at the Arnold Palmer Medical Center, addressed the topic "Grief

Work of Children" and led the attendees through a discussion about the emotional reconciliation needs of a grieving child. This session focused on the initial nurturing around the funeral phase by discussing six needs that can be addressed with a good funeral process. Such great information for the families that funeral professionals serve every day.

June 17th, Lance Ray addressed the topic of ethics in his presentation "Good People, Unethical Choices." He reviewed why ethics are so important to the funeral profession and discussed, in detail, the three parts of bad choices, and why we all must work to keep ethics high in our business. The discussion shared situations and ethical choices funeral professionals have had to make or have heard of others making in and out of the prep room.

No matter the age, a child's death is an immensely difficult loss and carries with it profound emotions. David will speak to us about many of these feelings along with finding meaning in death.

FEMA Policy Change



On June 29, 2021, FEMA amended the COVID-19 Funeral Assistance Policy ("Policy") related to deaths that occurred

in the early months of the pandemic. The original Policy stated a death certificate needed to attribute the death directly or indirectly to COVID-19.

The amended Policy states that for deaths occurring from Jan. 20 to May 16, 2020, any death certificate that does not attribute the cause of death to COVID-19 must be accompanied by a signed statement listing COVID-19 as a cause or contributing cause of death. The signed statement must be provided by the original certifier of the death certificate or the local medical examiner or coroner from the jurisdiction in which the death occurred.

The statement must provide an additional explanation, or causal pathway, linking the cause of death listed on the death certificate with COVID-19.

For deaths that occurred after May 16, 2020, the death certificate must indicate the death was attributed to COVID-19...

Commemorating First Responder Officer Enmanuel "Manny" Familia

Officer Enmanuel "Manny" Familia, 38, drowned while attempting to rescue a 14-year-old boy in Worcester, Massachusetts, along with two other teens on June 4, 2021. He served as a police officer for the City of Worcester for five years.

Officer Familia made a huge impact on the community he served; he was a member of the Tactical Patrol Force, the Crisis Intervention Team, a Crisis Negotiator, and a Department Recruitment Officer. Officer Familia was currently training to become a member of the SWAT Team. Prior to becoming a Worcester Police Officer, Manny worked as an officer for the Oakham Police Department, Quinsigamond Community College Police Department and the Clark University Police Department. He had been a Supervising Officer for the Department of Youth Services, Youth Apprehension Division. Off duty, Manny represented the WPD participating in various charities including the Tarantino 5K, WPD Basketball Team, Tarantino Softball Tournament, and the United Way

and Boys and Girls Club Dodgeball Tournament.

Officer Familia is survived by his wife of 22 years (whom he had known since he was 12 and was his high school sweetheart), his son and daughter, his mother and father, two brothers, a sister, many aunts, uncles, and in-laws, and his brothers and sisters of the Worcester Police Department.

He was honored by police, firefighters, and community members who lined the streets as his body was transported from the hospital to the Office of the Medical Examiner on Saturday, June 5. A Mass of Christian Burial was held Thursday, June 10, with interment in Saint John's Cemetery, Worcester. Mercadante Funeral Home & Chapel assisted the family with arrangements.

Commemorating First Responder Firefighter Ralph DeBlasi



Ralph DeBlasi, 62, of the No. 7 Township Fire & Rescue in Craven County, NC, died June 10, 2021 in a wreck during bad weather while responding to an emergency call. He had served with the No. 7 since

2017 after moving from Stamford, CT where he served the community for 32 years. Ralph was known as an inspiration and mentor among his brothers and sisters at No. 7.

Mr. DeBlasi is survived by his wife, Gina, sons, Michael and David, two siblings, and the community he served.

He was honored during services on Saturday, June 19 after which firefighters formed a procession with lights flashing from the Cotten Funeral Chapel to Greenleaf Cemetery. North Carolina State Highway Patrol escorted DeBlasi's cremains in a horse-drawn military wagon. Cotten Funeral Home assisted the family with arrangements.
