#### **Licensee Acquisitions**



On April 8th, Wilbert Funeral Services, Inc. acquired Maki Family Precast Concrete Businesses of Oxford and West Barnstable,

Massachusetts. The company consists of two precast operations and two burial vault operations. The two burial vault operations, Flagg-Palmer Vault Company and Century Vault Company were Wilbert<sup>®</sup> vault distributors for Norwalk Vault prior to 2008. In addition to being Wilbert distributors, they also manufactured Doric<sup>®</sup> and

Eagle<sup>®</sup> burial vaults. The acquisition of these two burial vault companies enables WFSI to convert the competitive product to Wilbert vaults, all within the existing footprint of our internal licensed territory.

On January 15th, Fred Sannipoli sold Whited Cemetery Service in Menifee, CA, to Matthews International's Memorialization division. Fred's son, Freddie, will oversee the vault operation for Matthews in Menifee. The name of the company will remain Whited Cemetery Service.

# Wilbert Hosts Informative Webinars on COVID-19 Financial Assistance from FEMA

On April 12, 2021, the Federal Emergency Management Agency (FEMA) began offering funeral assistance to families who lost loved ones due to the coronavirus (COVID-19) pandemic. Under the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 and the American Rescue Plan Act of 2021, FEMA will provide financial assistance to families for up to \$9,000 for COVID-19-related funeral expenses incurred after January 20, 2020, until September 2025.

To provide this information to the Wilbert Licensee Network, Mike Nash, Mark Bates, Ken Moore, and Terry Whitlock hosted a webinar Wednesday, April 14, and provided a presentation to the attendees about the omnibus Covid relief bill. The hosts outlined eligibility requirements, items needed by an applicant(s) to receive benefits, what funeral expenses are covered for reimbursement, and how the Wilbert Licensee Network can help provide this information to their funeral customer base.

This presentation was well-received by the Licensee Network. Many webinar participants felt it would be best to send this same message to their customer bases as a non-credited WilbertEDU session; therefore, Wilbert made a similar presentation to several hundred funeral-



home customers Tuesday, April 20. There were multiple comments from these attendees who did not know this benefit was being made available to families. Because of this, they found the webinar very informative and now will help those families who qualify for these benefits.

A letter for Licensees to send to funeral-home customers has been made available, which describes in detail this program. Additionally, fillable PDFs for funeral homes to send to their impacted families are also available. The unique design provides six companion niches across the bottom two rows by omitting some of the vertical score lines and 12 standard niches across the top two rows.

WilbertEDU continues to be a huge success! Thanks to all of you and your outreach to funeral professionals, we again broke our record for

registrations to our webinar with David Kessler, Death by Suicide. If you missed it, please head to the resource page to watch the recording because David is the highest rated speaker to date. Death by suicide is one of the most devastating losses that families face. Yet old beliefs are being replaced by new information on mental illness and brain science. David shared some helpful information on how to help families deal with the why of suicide as well as techniques to help families cope with all the "what ifs" and "if only's." He talked about how we can understand ways to test if consoling techniques will help after this type of loss as well as help us learn new ways to understand mental health. David Kessler is the world's foremost expert on grief and loss. His experience with thousands of people on the edge of life and death has taught him the secrets to living a happy and fulfilled life, even after life's tragedies. He is the author of six books, including the new bestselling book, Finding Meaning: The Sixth Stage of Grief. He coauthored two books with Elisabeth Kubler Ross, including On Grief and Grieving updated her five stages for grief. His first book, The Needs of The Dying received praise from Saint (Mother)

Teresa. He will be making two more appearances with the next one in July discussing "When a Child Dies."

Presenting on April 22nd, Wayne Stellmach of Wilbert Funeral Services, Inc. presented on "Better Communications with Families". Currently a marketing consultant for Wilbert, many of you know Wayne from his time with Wilbert as Director of Marketing where he provided marketing and communications to the various Wilbert Group organizations. He also has written articles published in funeral service publications and served on the boards of the International Memorialization Supply Association (IMSA) and the Funeral and Memorial Information Council (FAMIC), chairing the marketing committees of both. His presentation outlined the challenges of communicating with families during arrangement conferences, including the emotional state of families, distractions that are ever-present, and the different learning styles of family members. This course presents research on families' knowledge of OBCs; three basic learning styles that people have; how people evaluate major purchases; and how to engage and communicate with all the learning styles in the presentation of burial vault information.



#### **Commemorating First Responder Deputy Sheriff Christopher Knight**

Deputy Sheriff Christopher Knight, 30, of the Bibb County Sheriff's Office died April 6, 2021. Deputy Knight, along with another deputy, was moving a prisoner to an observation area after the inmate made suicidal comments. The prisoner was able to grab Deputy Knight's knife and stabbed both deputies. Deputy Knight had served with the Bibb County Sheriff's Office since 2018.

Mr. Knight leaves behind a 2-year-old daughter, his parents, and a host of relatives and friends.

Public visitation was held Monday, April 12, 2021 at the Richard R. Robinson Funeral Home in Macon, GA. A Celebration of Life took place at the Macon City Auditorium on April 13, followed by interment at Macon Memorial Park Cemetery. December 24, 1982 - EOW March 25, 2021

Corporal Kyle Davis, 38, of the Washington County OK Sheriff's Office, died of a ruptured aorta after being assaulted inside the Correctional Facility while booking a prisoner. He began his career in law enforcement with the Washington County Sheriff's Office in 2008 and was promoted to Deputy Sheriff in 2010. Mr. Davis is survived by his wife, two children, his parents, his sister, two grandmothers, a nephew, and his brothers and sisters of the Washington County Sheriff's Office.

A celebration of Kyle's life is scheduled for April 2, 2021 at the Copan gymnasium in Copan, OK. Interment will be in the Dewey Cemetery, directed by the Stumpff Funeral Home & Crematory in Bartlesville, OK.

#### **Commemorating First Responder State Trooper Joseph Gallagher**

NY State Trooper Joseph Gallagher, 38, died on March 26, 2021 from injuries he received in 2017 when he was struck by a vehicle during a stop to assist a motorist whose vehicle had broken down on the Long Island Expressway. He had served with the State police since 2014. Before his career with State Police Troop L, he earned a degree in marine engineering at the SUNY Maritime College. He then became a US Coast Guard pilot, flying helicopters on patrol and rescue missions throughout the Great Lakes.

Trooper Gallagher is survived by his wife, two children, parents, sister, and brothers.

Visitation was held on Wednesday, March 31 at Bruggemann Funeral Home in East Northport, NY, and then again along with full honors on April 6 and 7 in Orchard Park, NY, at Cannan Funeral Home. Trooper Gallagher was laid to rest at Our Lady of Victory National Shrine and Basilica in Buffalo.

#### **Commemorating First Responder Volunteer Firefighter Jared Lloyd**



Spring Valley, NY volunteer firefighter Jared Lloyd, 35, died March 23, 2021 while fighting a fire at an assisted living facility. He and the other heroes on Columbian Fire Engine Company No. 1 safely evacuated 112 residents that day before Jared sent a mayday call from the 3rd floor of the building. Jared had served the Spring Valley Volunteer Fire Department since 2006, rising to the rank of 2nd Lieutenant. Mr. Lloyd is survived by two young children, his mother and stepfather, his father, his longtime companion, grandmother, two aunts, an uncle, many cousins, and his CFEC family.

Escorted by the Rockland County Police Emerald Society Pipes & Drums Band, Jared Lloyd was given full fire department honors during the service held April 3, 2021 at Palisades Credit Union Park in Pomona, NY. A procession past the Columbian Firehouse led to his burial and rest at Brick Church Cemetery in Spring Valley, NY. Wanamaker & Carlough Funeral Home assisted his family with arrangements.
